Public duties:

Stamp Duties: 1% of the case value subject to a minimum of HUF 5,000 and maximum of HUF 250,000

Healthcare contributions: 27% of the arbitrators' fees

The Arbitration Fee will consist of the aggregate amount of the administrative expenses, arbitrators' fees and public duties. Figures and ratio shown in this Schedule as arbitrators' fee means fees due to one arbitrator. In the event of a tribunal such amounts will be multiplied by the number of arbitrators. The fees of the chairman of the tribunal and the sole arbitrator will be calculated as the arbitrators' fee plus 30%. Public duties will be paid to the State in accordance with the legal regulations prevailing at all times. If public duties change due to amendments to the legal regulations during the proceedings, this will have a corresponding effect on the Arbitration Fee. In the event of the increase of the public duties the balance will be deposited prior to the conclusion of the arbitration. In the event of decrease the balance will be due back, upon the settlement of accounts, to such Party that advanced the fees.
